High yield allocations added to state-specific tax exempt funds

Effective December 7, 2018, Foresters Investment Management Company, Inc., (FIMCO), the investment adviser for First Investors Funds, is making a number of changes to help improve the overall competitiveness of several vehicles in our mutual fund family.

To this end, FIMCO has hired Green Square Asset Management, LLC, an experienced specialist in the management of high yield municipal bonds, to subadvise high yield sleeves in the First Investors California Tax Exempt Fund, First Investors New Jersey Tax Exempt Fund, First Investors New York Tax Exempt Fund and the First Investors Oregon Tax Exempt Fund. Clark Wagner and Patrick Tucci, co-Portfolio Managers for Tax Exempt Funds, will oversee the amount of each Fund's high yield allocation. The Funds are expected to maintain their overall investment grade credit ratings. These represent FIMCO's remaining state-specific tax exempt funds following a reorganization, scheduled to occur on December 14, of several other single-state funds into our First Investors Tax Exempt Opportunities Fund.
